REGULAR MEETING MINUTES

From January 20th, 2026

The Harlan County Board of Supervisors met in regular session Tuesday, January 20th, 2026, in the Community Room of the Harlan County Courthouse in Alma, NE, as advertised in the Harlan County Journal and posted on the County website harlancounty.ne.gov, with Supervisors Mike Clements; George Scott; Cindy Boehler; Rob Schmidt and Janice Miller-Boston present. Also, present was County Clerk Jessie Martin, Highway and Weed Superintendent Tim Burgeson and County Attorney Whitney Schroeder, County Assessor Kim Fouts, County Treasurer Brittany Artz, County Sheriff Jesse Langley. Absent was Jeff Bash and Joe Schnuerle

At 9:30am Chairman Boehler called the meeting to order, announced that there is a copy of the Open Meetings Act posted at the south end of the room which will be followed by the Board. The Pledge of Allegiance was recited.
